





7.5 Duties of Managing Committee Members:






- 8.2 To receive any money or other assets in any shape or form as gift or donation and to hold the same as capital fund and/or apply it for furthering the objects of the Trust.
- 8.3 To acquire construct or to dispose of through sale mortage, hire, lease or otherwise movable or immovable, tangible or intangible properties, and rights and benefits and to manage the same.
- 8.4 To represent the trust in all courts (original and Appellate) or before Judicial or Quasi-Judicial authorities and other authorities, departments of Government, semi-government or local authority.
- 8.5 To borrow or raise any money that may be required by the trust upon such terms as may be deemed fit and to secure any moneys so borrowed by mortgage or charge of all or any part of the assets belonging to the Trust.

10. MEETINGS AND RESOLUTIONS:

- a. General Body: The General Body of all the Trustees shall meet at least once a year to adopt the audited Accounts, and Budget and appoint Auditors and elect a Managing Committee as and when necessary.
- b. Special General Body Meeting: The management may call a Special General Body Meeting if it deems fit. However, if a requisition is made by 2 Trustees or 25% of the total number of Trustees whichever is more the management shall call the Special General Body Meeting and discuss the matters as given in notice. In case the managing committee fails to act on the notice, the persons who sent the notice may themselves call a meeting and take necessary decisions. Any such decisions taken shall be binding on the Trust.
- c. Managing Committee: The Managing Committee shall meet as often as the circumstances require to transact the business of the Trust. There shall at least be Three meetings in one year.



11. WINDING OR DISSOLUTION OF THE TRUST:

It is hereby declared that the trustees have power to wind up the Trust, by merging or amalgamating with another Trust, charitable society having similar objects.
