AIMS AND OBJECTIVES OF THE COMMITTEE:

- 1.To develop a policy against sexual harassment of women at the Institute.
- 2. To evolve a permanent mechanism for the prevention and redressal of sexual harassment cases and other acts of gender based violence at the Institute.
- 3. To ensure the implementation of the policy in letter and spirit through proper reporting of the complaints and their follow-up procedures.
- 4.To uphold the commitment of the Institute to provide an environment free of gender based discrimination.
- 5. To promote a social and psychological environment to raise awareness on sexual harassment in its various forms.

CREATING AWARENESS AMONG STUDENTS, STAFF AND FACULTY:

1. An orientation seminar will be organized to discuss the nature and scope of the sexual harassment of women at the workplace (Prevention, Prohibition and Readressal) Act 2013, at the beginning of the academic year.

2. One or more workshops/seminars annually where external experts on the subject will interact with all employees and students

3. Seminars, performances and discussion forums where gender sensitization and gender awareness will be the focus – these will happen during the academic year.

4. Spreading awareness of the policy and implementation of the same through informal sessions, performances, cultural events, etc., about the policy being implemented by IIPS



Nomen's Cell Convence;

COMPLAINT PROCEDURE:

- 1.Any woman employee or female student have the right to file a complaint concerning any harassment including sexual harassment against a male student /employee /faculty /administrative staff / research staff / any of the members of the Committee as the case may be.
- 2. All complaints will only be accepted in writing. The Committee is allowed to take action even in the absence of a written complaint.
- 3. The complainant shall be afforded full secrecy at each stage.
- 4. The name, address, identity or any other particulars calculated to lead to identification of the COMPLAINANT shall be kept confidential and will not be disclosed even to the Committee, till the meeting in this regard is convened.







